The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): The Food and Drink Advisory Partnership (FDAP) came to its scheduled conclusion at the end of October 2011. The FDAP was replaced by a newly appointed Food & Farming Sector Panel, as part of this sector being made a priority sector within the Department for Business Enterprise Technology and Science (BETS).. As a sub-group of FDAP, the Dairy Strategy Group was also disbanded, and I wrote to the Group's chair to inform him of this decision, and to thank him personally for his involvement. Attendees of all FDAP sub-groups were advised that the FDAP would be coming to an end in 2011, and that industry sub-groups of the new Panel would be a matter for the Food & Farming panel to consider.

The Food and Farming Sector Panel was formed to ensure that the views and priorities of the whole food and farming industry, inform the Welsh Government's policy development, and provide Ministers with expert knowledge and advice.

I will be holding a Dairy Summit this summer. This will form part of an on-going close engagement with the dairy industry, and is an important opportunity to discuss what is needed, who can best deliver it, and how we can act together to secure a profitable future.

The Minister for Health and Social Services (Lesley Griffiths): The management of chronic diseases, including fibromyalgia, is a high priority for the NHS in Wales, which is required to put in place appropriate measures to ensure prompt diagnosis and appropriate treatment for patients and to ensure care and support is provided in the right setting, by the right professional. We do not hold information centrally on the prevalence of fibromyalgia. Health Boards are responsible for assessing the needs of their local populations and ensuring services are delivered to meet those needs.

To assist Health Boards in the management of this condition, the Fibromyalgia Care Pathway was published on 18 March 2011 in consultation with clinicians and service users. I expect all Health Boards to plan and deliver services in line with the care pathway.

My officials will be asking Health Boards for an update in due course in relation to how services have improved as a result of the introduction of the care pathway.
