The Minister for Finance and Leader of the House (Jane Hutt): A comprehensive review of our relationship with sponsored bodies was undertaken during 2009-10 which included a review of governance and financial control frameworks. This resulted in a new model Framework Document being put in place. The Framework sets out the respective roles, responsibilities and accountabilities of the WGSB and the Welsh Government. It places responsibility for ensuring each WGSB has in place sound financial and other management controls with the relevant Welsh Government Additional Accounting Officer supported by a Sponsor Team. Sponsor Teams meet regularly with WGSB officials to review and monitor financial performance and achievement of objectives.

Regarding core funding of other organisations, the Grants Management Project has been set up to improve grant administration across the Welsh Government. Officials are currently benchmarking all grants against minimum standards and making recommendations for improvement where appropriate. A Centre of Excellence has also been set-up to provide advice and support, and develop grant practices generally.

The review of grants includes the assessment of organisations requesting grant funding. The project is ensuring that all organisations requesting financial support from the Welsh Government are assessed on a risk based approach which includes their financial integrity.
