Dear Tom,

I write in response to WQ90269: Will the Minister detail what the impact of the £19 million of cuts to the employability and skills budget will be, and set out any additional long-term costs to the Welsh Government?

Annex A, in the attached link, provides you with information in relation to the Strategic Integrated Impact Assessment within the Budget Narrative: <u>Draft Budget 2024 to 2025 |</u> GOV.WALES

Skills and employment remain powerful tools to tackling poverty. Well-paid work is the best route out of poverty and the greatest protection against poverty for those at risk. It can also be a key factor in maintaining physical and mental well-being.

We are reprioritising £19m of funding for employability and skills budgets that enable delivery of key employability activities, including Communities for Work Plus, Jobs Growth Wales Plus and ReAct Plus. These programmes and/or their predecessor programmes relied heavily on European funding, up to £30m per annum; however, disappointingly the UK Government has denied the Welsh Government any decision-making role or access to EU replacement funds through the UK Shared Prosperity Fund, so these programmes cannot continue to operate as they have done previously. The UK Government has also failed to replace EU funds in full, resulting in a shortfall of nearly £1.3 billion in real terms for Wales during the period January 2021 to March 2025; this means it is not just our employability and skills programmes that are affected.

While we have needed to reprioritise funding within the available budget, we are considering how programmes can be targeted to maximise the chances for all groups of people to obtain sustainable work across Wales. We have protected support for 16-19 year olds as far as possible and equality remains a key priority for us. An example of this is our ongoing support for disabled people through our apprenticeship employer incentive. We also recognise that
