The Deputy Minister for Children and Social Services (Gwenda Thomas): The National Adoption Service will be developed by the Adoption Expert Advisory Group, with an expectation that tangible improvements will be introduced prior to the establishment of the new service within the next two years.

The Bill will also require Local Authorities to come together to deliver key adoption services through greater collaboration and co-operation across boundaries, thus harnessing the specialist nature of the adoption service.

Through the Social Services (Wales) Bill we will underpin these arrangements with a coherent National Outcomes Framework.

Ownership and delivery of the National Adoption Service will be for local authorities, but there are a range of key partners including the Welsh Government, Voluntary Adoption Agencies, Welsh Local Government Association as well as other voluntary organisations.

Lesley Griffiths: Claire House Hospice provides palliative care services for children and young adults with life threatening or life limiting conditions from Merseyside, Cheshire, the Isle of Man and a very small number of children from North Wales. The low numbers mean it is not appropriate to provide specific figures as this could identify individual patients.

Claire House Hospice is situated on the Wirral and therefore does not receive funding from NHS Wales. The main provider for children's palliative care for North Wales is Ty Gobaith/Hope House Children's Hospice in Conwy and Oswestry. Referrals to any hospice are made by Health Boards on the basis of patient need.

Lesley Griffiths: Our commitment to provide one school nurse per secondary school was achieved in May 2011. This has involved an investment of $\pounds 2.4$ million over the last four years. All Health Boards have made a commitment to sustain the investment.

My officials are working with the service to continue to implement the school nursing framework across Wales and are preparing proposals for the next phase of service development. I am expecting to receive these proposals in the autumn.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): The Welsh Government considers that the pre-ballot costs incurred and submitted by Flintshire Council are reasonable and that the Council carried out the pre-ballot process in accordance with our 'Housing Transfer Guidelines'. This requires the Council to ensure that tenants are able to obtain independent advice on the transfer and must appoint an Independent Tenants Adviser (ITA) at an early stage in the pre ballot process.

The role of elected members in advising tenants is not covered by the Guidelines but we are satisfied that Council tenants had access to impartial, independent advice to make an informed decision. In Flintshire's case the ballot result was clear. There was a turnout of 71%. 12% were in favour of transfer and 88% were against.

A Ministerial Taskforce has been established to advise on potential options for the three 'no' vote Local Authorities (including Flintshire) to support them to meet the Welsh Housing Quality Standard within an acceptable timeframe.
