**The First Minister (Carwyn Jones):** Remembrance Day 2014 will hold special significance as part of the Centenary of the First World War, which will be marked by events and ceremonies within Wales and beyond, including Remembrance Day 2014.

I was pleased to announce in March that Sir Deian Hopkin is my expert advisor for commemorative activities to mark this Centenary. He is advising me on how best we can remember the conflict, and its impact, and engage with the Welsh public organisations as well as the Imperial War Museum.

During our recent meeting, Sir Deian provided me with an update on meetings and discussions he has had with interested parties, future discussions will include specific arrangements for Remembrance Day 2014.

We must ensure that the Commemoration leaves a legacy for children and young people in Wales. I am aware that our cultural bodies have already begun preparing activities for 2014. The National Library has received £500,000 in funding from the Joint Information Systems Committee for digitisation of primary sources relating to the First World War, in partnership with the libraries, special collections, and archives. Our national and local museums and archives are also developing resources and planning events that will help us better understand the conflict.

**The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies):** I have made my position very clear on commercial decisions within the red meat sector regarding moves to direct payments, in WAQ60635, and again in WAQ60721.

On your broader point, as outlined in the Strategic Action Plan for the Welsh Red Meat Industry, the Welsh Government supports the development of co-operative networks to strengthen branding, market share and market intelligence, and to provide training opportunities. Cooperation and transparency within the Welsh red meat supply-chain, are both key to achieving a profitable, efficient, sustainable, and innovative Welsh red meat industry which in turn is able to respond competitively to ever changing market trends.

NHS organisations are required to submit monthly financial performance data to the Welsh Government. This data includes a number of financial indicators which provide an assessment of the effective use of funding, including, for example, expenditure on agency and locum staff. The data is collated and shared individually and collectively with NHS organisations, and is also used by the Welsh Government to review progress against the delivery of service and financial plans.

NHS Wales organisations are using the 1,000 Lives Plus improvement programme to support individuals and organisations to deliver high quality and safe care for the people of Wales. **Lesley Griffiths:** We have undertaken a number of initiatives over the last few years to reduce medicines waste including running a medicines waste campaign and the introduction of targeted Medicines Use Reviews.

Health Boards are expected to prioritise activity to reduce waste, and look to GPs to take an active role in reducing medicines waste through responsible prescribing.

This policy should be under pinned by health professionals across the NHS who must take responsibility for ensuring medicines are prescribed, dispensed and used appropriately by patients to reduce avoidable waste.

**Lesley Griffiths:** The Welsh Government remains committed to improving the diagnosis and treatment of people with rare diseases throughout Wales.

The UK Plan for Rare Diseases, currently being developed, will help address these issues. The public consultation process has now closed and my officials are working closely with partners in the other UK countries to consider the responses received and to produce a final Plan for publication. Once this process is complete, I shall consider how best to implement the Plan in Wales.

Screening services in Wales are based on advice from the National Screening Committee, which advises all four health departments on existing and future screening programmes. Should the National Screening Committee recommend any further screening programmes for rare diseases, I will consider their implementation in Wales.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): War memorials are an important part of our heritage and a permanent reminder of the sacrifices brave men and women made, and of the losses sustained by communities in Wales.

The Welsh Government does not hold information on the amount spent by local authorities on the maintenance, protection and upkeep of war memorials. This information should be available directly from local authorities in Wales, although many memorials are maintained by community and town councils, local institutions and, in some cases, private companies.

During 2007 Cadw, the Welsh Government's historic environment service, provided grant funding of  $\pounds$ 7995 for the maintenance, protection and upkeep of listed war memorials and is currently considering a further application for £3000. Since 2007 only one application for funding has been refused and one application was withdrawn when an alternative funding source was found.

The Welsh Government is a member of the UK War Memorials Action Group (WMAG) which had been convened in response to the approaching centenary of the First World War and recent campaigns to improve the condition of war memorials across the UK. The War Memorials Trust is also a member of

WMAG. The Welsh Government is also supportive of the partnership project 'We still remember' between War Memorials Trust and the Imperial War Museums. One of the factors inhibiting the protection of war memorials is that no centralised record was ever made of exactly what was being erected, where and by whom during the inter-War prolific phase of memorial construction. The UK National Inventory of War Memorials was established in 1989 to try and record memorials of the First World War, and all other historic conflicts. To date approximately 62,000 memorials have been recorded in the UK, but the original number is unknown. The 'We still remember' project will build on this work and develop a single integrated web resource to facilitate access to wide ranging data on war memorials in the UK. It is intended that this resource will be interactive and an important tool in encouraging greater public engagement with our war memorial heritage, particularly in the approach to the centenary of World War I. The resource will also incorporate condition information which should allow funding to be targeted to the memorials most at risk.

In Memoriam 2014 is a partnership between the War Memorials Trust and the SmartWater Foundation to provide greater protection for war memorials across the United Kingdom. This excellent project has my full support and will further assist communities in Wales in preserving their war memorial heritage. The Welsh Government itself wishes to ensure that there is a fitting response to the sacrifice of many Welsh people in the World War 1 conflict and the First Minister has appointed Sir Deian Hopkin to advise him on an appropriate commemoration programme which will be inclusive in its approach. Sir Deian is currently meeting with stakeholders both within Wales and beyond to scope this work.

Metal theft is a serious and growing national problem with social and financial impact on individuals, communities and businesses and the Welsh Government continues to work closely with the police and other authorities in combating all metal theft of all kinds in Wales. In order to make it more difficult for criminals to sell the metal they steal, officials from Welsh Government are working with DEFRA (Department for Environment, Food and Rural Affairs) to examine whether it should be possible to refuse or revoke a waste management licence or the registration as a waste carrier, for a person who has been convicted of offences for metal theft. The Welsh Government is also working with the Home Office and DEFRA to review legislation to help enforcement agencies prevent/discourage theft and to give powers to take regulatory action. Funding has been obtained to fund a full time co-ordinator for the Police forces across Wales. This will enable better cross border partnership working and an improved all Wales response.

The vandalism of our war memorials is an insult to those who sacrificed their lives and to the communities they served and who wish to commemorate them. The War Memorials Action Group discussions are focusing on a number of key issues to protect local memorials and one of these is raising public awareness. My officials in Cadw have also established an internal working group to identify practical solutions to heritage crime issues, including vandalism. Where problems have been identified, Cadw has been actively engaging with the local communities, with local police and other agencies to combat this antisocial behaviour.

Of these projects, four are complete and three are currently forecast to exceed their initial budget allocation. The transport capital budget is run as a balanced programme of schemes and whilst some schemes are forecast to be over initial allocation of budget, others are under.

In addition, the Welsh Government has contributed to 2 Local Authority schemes through transport grant, both are within budget with 1 due to complete shortly.
