Lesley Griffiths: Our aim is to reduce the risks of developing Type 2 diabetes by encouraging people to adopt a healthy lifestyle, particularly not smoking, drinking sensibly and maintaining a healthy weight.

Several campaigns are part of our broader response to help people achieve and maintain healthier lifestyles and live longer.

We are currently working with health professionals to develop a Diabetes Delivery Plan for Wales. The Plan will be issued for public consultation by December of this year.

Lesley Griffiths: Together for Mental Health outlines our new all-age Strategy for mental health and wellbeing in Wales. It aims to improve the lives of people with mental health problems, and, where possible, prevent such problems developing in the first place. The Strategy will promote mental wellbeing by improving awareness, information and advice about mental illnesses in all ages, including older people.

As part of Together for Mental Health, we will continue to implement the Strategy for Older People in Wales, which includes the promotion of mental health and wellbeing. Staff in the NHS, Local Authority and Third Sector, including Primary Care Mental Health workers, who come in contact with older people, will receive training to ensure they recognise and respond to signs and symptoms of mental illness such as depression in older people.

The Mental Health (Wales) Measure 2010 has established new Local Primary Care Mental Health Services, and GPs and primary care staff will be trained and supported to improve early identification and recognition of depression amongst older people. The Measure, prescribes that Care and Treatment Plans for older people receiving secondary mental health services should identify and support any mental illness including depression. The Intelligent Target for depression also aims to improve the rate of its detection amongst older people receiving physical healthcare in general hospital settings.

The Deputy Minister for Children and Social Services (Gwenda Thomas): We are developing a National Outcomes Framework for Social Services in Wales which will give us a structure to describe and measure the well-being of people who need care and support. The Framework will use a number of outcome statements which focus on the individual. These outcomes statements focus on health (physical, mental and emotional), education, social and economic well-being, and rights amongst other areas and are the key areas where social services can make a difference to people and their lives.

The Framework will include high-level outcome measures of the well-being specific to different groups, including older people. We will also include measures of satisfaction with services in the Framework.

I will be consulting on our approach to developing the Framework in November.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): The land at Bodlondeb Fields has been proposed for development by Conwy County Borough Council in its Local Development Plan. On Cadw's advice the Welsh Government responded to the consultation querying the inclusion of this site which is within the designated essential setting of the World Heritage Site. Cadw has since had further discussions with the Council and concluded that some form of development of the site could be possible if carefully designed and landscaped. It is for the Council as owner to make decisions on whether the land should be developed or left as open space but Cadw will continue to liaise with them and offer advice where appropriate. Should the development proposal go ahead the decision on the appropriateness of the inclusion of the site in the Local Development Plan will be for an independently appointed Inspector to determine in due course, based on the evidence and any representations submitted.
